### **Review Mar 2015 Minutes:**

### **Framework:**

Bob Denouden: Framework data development funding proposals were all due on April 14<sup>th</sup>. Amended Soils Data Standard has come in and is under review. Meta Data Standard workgroup met on April 15 to discuss how to proceed; this Standard will be on the agenda at the upcoming Framework Forum (May 20<sup>th</sup> Framework Forum, which will be held in Salem at the Chemeketa Center for Business and Industry.) The Fish Habitat Distribution Data Standard is under review. Elevation FIT has a new Chair; Jake McDonald has stepped forward to take leadership, and is awaiting OGIC approval. Geoscience's lead Ian Madin has stepped down and Lina Ma has stepped forward as new FIT Chair, pending OGIC approval.

Hydro FIT met recently to review proposal for funding standards for both Federal and State monies. This FIT also created an online study for stakeholders (Federal and State) to look at the ROI on the Hydro standards efficacy. Coastal Marine FIT met last week and they are currently working on formalizing their data elements.

### **Annotation of Framework Layers:**

R. Dana: There is an identified need for an online tool to track issues about LIDAR data. This idea originated out of the Coastal data work that Randy Dana and Lincoln County used to track errors/issues in datasets, and then recently resurfaced again while working on the Shoreline Datasets. GPL members believe that such an online tool could be applied to other Framework datasets as a bug tracking tool. It was decided to bring that topic up following the framework report. Randy Dana, Josh Tanner and Bob Denouden will follow up.

## **Shared Services**

C. Smith and Gail are still trying to advance the procurement for designing shared services collaboratively. It's important to layout the framework/governance before the effort starts moving in multiple directions.

## **GEO Move:**

Cy Smith: Moving along – DAS Geo would remain as part of the CIO office but will be moving over to and working closely with DLCD. DLCD is very supportive and want the Shared Services approach to work. Move should happen by the end of April 2015, however the DAS interim director has recently put a hold on the move pending a better understanding of the proposal.

## **ELA/OGIC:**

Cy Smith: Met two times with ESRI on ELA and will have a second stakeholders meeting this Friday (April 17, 2015). In terms of OGIC we talked about a revision of the executive order (EO) and Cy was asked to create a draft and then run it through the policy advisory committee. In revising the EO will look at revising the structure of OGIC and the Funding mechanism.

## **Developers Conference**

Dave Mather/Josh Tanner: Dave presented updates and info related to Enterprise Architecture and Design on ArcGIS Server 10.3 and Portal. ESRI states that the simplest design is really the best approach for ArcGIS Server site setup.

GEO is looking into the idea of critical core (process that has to be up 24-7) versus community core (issues that are project based). The idea is separating architecture/infrastructure so that you are not taking down one machine. ESRI also recommends against clustering.

Overall Theme and Key topics of Conference: Shared application development environment, Vector Tiles, and Smart mapping, and JavaScript, and AppStudio.
