Used Terminus via MS Teams to collaborate with State, Federal, and local contacts via a virtual environment.

During the response, Shoreline Assessment records were collected via Survey123 (SKAT) survey and then submitted and then uploaded in real time. Agency's involved: NOAA, Coast Guard, EPA, WA. Dept Ecology, DEQ, Oregon Health Authority, State Parks, ODFW, Parks and Rec.
