Framework Program Inventory


- Nearly Complete

Framework Grant Program Recommendations

Initial Concerns

- 70% Foundational/30% Secondary data element funding split
- Opportunities to better align OGIC funds to OGIC's priorities
- Review process does not take into account newly formed committees
- Grant Program Request for Proposals did not encourage or prioritize projects in alignment with OGIC Goals






Framework Grant Program Review

- Request for Proposals put on hold in April 2023.
- OGIC's Data Sharing Committee Reviewed Program.
- OGIC voting on Committee's proposed recommendations in tomorrow's OGIC meeting.



Recommendation 1:

Create budget allocations for the OGIC fund to support the goals and objectives outlined in OGIC's Strategic Plan; Regular Executive Committee reporting on OGIC fund.



Recommendation 2:

Eliminate 70/30 Funding Split; use multiple criteria to aid in the selection of projects to fund.
