  - Agenda update
  - Announcements
    - GPL September (9/14) meeting w/ TAC
    - [Esri Imagery Summit](#), 10/19-20

    - November GIS Day (11/17); start thinking about; capacity to hold; ideas?
- DAS-GEO report, Cy
  - Cy retiring 11/12/21; working 2-days a week until then (Tues. & Thurs.)
  - Working on GeoHub roads project (from POP; other POP funded 3 pilot projects)
    - working with road data aggregators (METRO, Washington County, PBOT; LCOG, Lane County; and, ODOT)
    - Getting data and improving assembly process
    - Focus groups working on data preparation
    - Kick off might happen in October
  - Cy working on Esri interagency agreements
    - “Not to exceed amount” needs to be amended in all of the agreements; not much will change
    - Try to extend contract period out to end of the 4-year agreement (we're in year 2)
- OGIC report, Cy
  - Had meeting recently (7/29)
  - Shoreline standard and stewardship plan approved
  - Framework rules process; statute specifies that OGIC needs to layout rules to implement, define rules and conditions for sharing, for example; Council decided to wait on rules and proceed with processes: identification, update frequency, etc.
    - PAC brought recommendation to establish rules; OGIC did not accept
    - OGIC will work with PAC to identify elements

- Sustainable funding approach; how the Council wants to move forward with Legislature to create a sustainable funding model, to complete and update framework themes
  - Discussion started and will continue
- Discussion:
  - No timeline
  - Element list and process for defining an element not formalized
  - Element list out of date
- FIT report and Update on FIT proposals, Cy
  - 5 proposals requesting ~\$350K; couple more might come in for imagery and broadband
  - Rubrics due and coming in to Cy
  - Review team will meet to discuss and finalize report to OGIC (~early Sept.); probably all 5 will be funded; OGIC should complete its review and make a decision by the end of Sept.; contracts can be issued after that (October)

  - OEM has been continuously activated for the wildfires
  - [get rest from recording]
  - Success with continued work on the statewide fire evacuation service; building up relevant data sets and data entry for tracking the animal sheltering data; jet A fuel status for fire response airports; working on consistent storymap series for displaying info overview
  - Room for improvement in data for damage assessment locally and related data sharing

    - Do reports on a regular basis work for GPL and Prep FIT?
    - Anything missing from reports?
    - Did you like content categorization in AGOL and access via the group?

  - Updated presentation to OGIC (attached)
  - State Data Strategy released earlier this year; [link](#)
  - Roadmap, timelines little bit off
  - GeoHub started
  - Legislative update
  - POP (2021-2023)
    - GeoHub proof of concept and ETL capabilities to be identified
    - 7 new FTE
  - Org chart
    - Vacancies: Cy (11/12) and Josh (8/2); CDO at <30% staff capacity
    - GIS will be in the Data Unit
    - New GIO in September (as Deputy CDO)
    - Dave Mather really busy (sole GIS support for at least a few months)
    - Working to onboard critical roles; hopefully at capacity by end of year
- Starting planning for 2023/2025 session

  - DEQ, Malavika
    - Environmental Data Management System (migration from Facilities Profile) continuing: recent migration of hazardous waste program
    - Increased AGOL licenses and reduced Desktop (ArcMap) licenses; discussion around move into Portal
    - GeoCortex installation, looking to move it into the cloud; discussions on approach
  - DOR, Thom
    - DOR project taking lodging address to determine whether they are in city limits (affects lodging tax); ~7600 addresses; used Esri Geocoder from Python script, create a point layer, and intersect with city limits and counties layers; being QC'd now; will loaded into AGOL with visualization tool (demo in fall)
  - OWRD, Bob
    - Staff busy with drought related issues—identifying and helping owners with dry wells, drought water right permits, etc.
    - Major update of S123 survey for dam safety inspections; release to field staff this week
    - Enterprise installation at the State Data Center continues with Esri tech support assistance; making progress
  - DOGAMI, Ed
    - No report (vacations)
  - OPRD, Brady
    - \$50 Million in general obligation bonds for infrastructure improvements in next 6-years; figuring out how to implement w/ reduced staff
    - Internal project; help staff on shared stewardship effort w/ USFS to enhance existing recreation opportunities and identify new ones
    - Imagery: goal of 2022 acquisition; scheduling call w/ NAIP aerial photography field office to coordinate planning; will update GPL
  - DHS/OHA, Tom
    - Working on new server at SDC; internet facing w/ ArcGIS Server; to integrate with reporting tools like Power BI

- Address Points FIT back on front burner
- Transitions at DHS; Aaron H working with DHS emergency management, make work with them on emergency prep (role change?)
- ODA, Diana
  - Hemp, making online maps, geocoding growers and handlers; Ag has to work with OLCC to inspect hemp grow facilities in Douglas, Jackson, & Josephine counties (750)
  - IPPM wrapping up Japanese Beetle trapping and spraying in Portland
  - Start on field burning
  - \*Manager wants to develop a AGOL governance doc; any input welcome
- DSL, Randall
  - Enterprise, move to 10.9 soon
  - Field Map issues and trying to get to work with Pro
- DLCD, Rachel
  - From recent legislative session: DLCD has to implement new public facing app to show city/county/special district inventory of surplus lands; have to start collecting information by end of this year with report due in Feb. '22; have app and database up and running soon
  - Wrapping up land use data set, standard, and stewardship plan (w/ Randy Dana and work group); about ready to go; metadata to be done and will be extensive; project successful, will handle updates from DOR; challenge with staffing like Parks
  - Staffing issues between last year's cuts and new tasks; flurry of hiring to catch up
- Coastal, Tanya
  - Adrian's fellowship almost up but found funds to keep her on another month and a half to work on web project
- ODOT, Phil
  - Update of state highway map, probably out in early 2022
  - TransGIS 4.0 coming out in next week or so
  - Gradually moving into Pro; change in licensing towards concurrent licensing (from name user)
- Marine Board, Joe
  - Working on grant history dashboard available to public when done
  - Work on facility survey tools in Survey123; will create data viewer with either Experience Builder or Dashboard
