GPL Report		
Brady Callahan	GPL recent discussion involved continuing grayness between the practice of GIS and the surveying community. The issue is that all the effort that was done by the task force on surveying and mapping may have fallen off the radar of the surveying community. At least one ruling relating to LiDAR by the Professional Practices Committee stated that LiDAR is the practice of surveying and has no bearing on what the data is used for or what the intent was. He would like the Council to suggest how GPL and GEO work together to revisit some of the Task Force issues.	
Action Items:	Dean Anderson responded that he is somewhat involved in this and that acquiring and setting up the ground control for LiDAR is the act of surveying. He offered to work with Brady to help clarify the issue. A subcommittee will be formed Brady, Dean, DOGAMI, Forestry, ODOT and Department of Revenue representatives to result in a recommendation at the next meeting of how we want to move forward.

ARRA Federal Stimulus Reporting/Tracking Tool Demonstration		
Dugan Petty/Cy Smith	The State Stimulus package "Go Oregon" provides public works money to help build projects that stimulate the economy. To manage it and effectively decide how these projects should be deployed in the state, development began on a tracking system. The tool leverages GIS data, employment data and ODOT project management which has web interface capability, to give us a powerful management tool that will be used for tracking both the State and Federal stimulus funds. Upcoming presentations are being made to the Governor's Economic Recovery Executive Team and policy advisors, CIO's, and Administrative/ Business Services Directors. FGDC CAP Grants		
Milt Hill	Application made to FGDC for 2 CAP grants; one was Category 3 to develop and implement a statewide strategic and business plan and the other a Category 7 to develop geospatial data partnerships across local, state and federal government. We were awarded the category 3 grant for \$47,000.	
2010 Imagery		
Cy Smith	At the last OGIC meeting, a collaborative financing effort was discussed. Since then, it was decided within DAS that we would put the \$275,000 forward to pay for the 2010 imagery. With \$75,000 from BLM and \$75,000 from ODOT we will be able to provide ½ meter true color and color infra-red imagery. With the additional funds, we will also be able to fund the increased hosting and access charges that we will have at the State Data Center, based on increased imagery volume. We may also be able to give local governments an opportunity to buy higher resolution imagery from areas within counties that they may want to have.
