Business Case	Cy presented the history of the previous presentation. Format of presentation seems to be of most concern. The OGIC sub committee is recommending more detail and a Program outline. Cy asked for input and recommendations. So far the outline includes four major categories to be covered. 1) Data Development; 2) Technology development; 3) Communication/ Coordination and 4) Inventory of Assessments. Part of the difficulty lies in the fact that there are no models to use – no one else has done this in this way.	One recommendation was to go back and use the POP format to get better detail on the presentation. Also – although the history piece is good, by separating its content and adding it to pages from the back of the original presentation it could give clarification to the report and look more like the Business Case that is being requested. Another recommendation was to add some emphasis to Tribal participation. And, by adding an executive summary that briefly gives the who, when and why for the proposal at the front would clarify the information on a CIO level.
